CONSUMER PRICE INDEX REPORT NOVEMBER 2007

(4th Quarter Report 2007)

Central Statistics Division

OVERVIEW

The prices for this fourth quarter of 2007 was collected on from 16th to 20th of November 2007. The prices were confirmed on the 21st November 2007. There were no substitution taken place for this quarter. The method of substitution is used when items are no longer on the shelve.

The Tuvalu Consumer Price Index (CPI) expression base is currnetly base on May (second quarter) 2006. Prices are collected from the following Outlets:

Fetuvalu High School, Falesa Gas, NAFICOT, Marine Department, Funafuti Fusi (Fakai Funfuti Branch), Samuelu Hardware, Kaupule Funafuti, Semaia Bus Service, Matagi Gali Bar, Vaiaku Lagi Hotel, Lucky Set Bar, Setusa & Pasefika Fish Market, Manaema Bakery, Telecomm, Travel Office, TEC, Personnel & Training Department, Bread Market, Sulani & Afelee Video Library.

Tuvalu Consumer Price Index Revision

The All Group Index of the Tuvalu Consumer Price Index (CPI) for this quarter of the year is an increase from 1037.97 of the previous quarter to 1051.02 for this quarter. This result in a quarterly percentage change of **1.26%** for which result in the net change of 13.05.

This change results in the annual inflation rate of **0.48%** for the last twelve months as compared to the inflation rate of **2.05%** of the previous quarter. Reasons behind this increase in the inflation rate are explained in the *analysis* of significant movement within indices (and therefore indicate which item or regimen have increase or decrease their prices).

Graph 1 on the next page shows the Annual Inflation Rate from 1997 to this fourth quarter of 2007. The Annual Inflation Rate is the difference of All Group Index in percentage between a current quarter and the same quarter of the previous year.

Table 1 on the next page show that there is an increase in the **average rate quarterly inflation rate** (average for all four quarters) for the last eleven years from 1996 to 2007. There is an increase from 2.83% in 2004 to 3.80% in 2006. However there is a decrease from 3.38% in 2003 to 2.83% in 2005. The reason for the decreases and increases in inflation rates have been explained in earlier quarterly reports for the mention periods.



The above table shows an increase in the quarterly overall index of **1.26%** from the previous quarter. The increase was mainly contributed by the increase of major group index such as Alcohol & Tobacco (6.09%), Food (1.73%) and Housing (1.21%). Miscellaneous have no change in their group index from the previous quarter. One group opposing the increase is transport with negative changes of 1.27%.

For the last twelve months there is an increase in the overall index of **0.48%**. This increase was contributed by major groups such as Alcohol & Tobacco (6.81%), Miscellaneous (0.23%) and Clothing & Textiles (0.17%). Three major groups shows a decline, Housing (-2.82%), Transport (-2.19%) and Food (-1.24%).

Significant movements within the indices:

(Contributions generally show the effect of items with price changed, sub-groups and major groups onto the overall net change of the CPI. It simply indicate the 'quantity added to or subtracted from the previous quarter all groups index' to provide the current CPI)

Food Group

The group records an increase of 1.73% for this quarter as compared to the previous quarter (from 995.72 to 1012.93). The increase is mainly due to the following increase of index for subgroup – Fruits & Sugar & Sweets (6.28%), Vegetables (2.51%), Beverages (2.03%), and Meat (1.33%). Opposing the

increase of subgroups is subgroup fish (-0.66%). The following are major increase for some of the commodities:

Offsetting the above increase is the decrease in the price of the following commodities:

•	Potatoes	-13.64%	(i.e. from \$2.20 to \$2.10)
•	Pears	-12.20%	(i.e. from \$0.60 to \$1.00)
•	Canned Mackerel	-2.56%	(i.e. from \$1.95 to \$1.90)

The group total contribution resulted from its items-to-price with change in price is 5.78

Alcohol & Tobacco

The group records an increase of 6.09% to the overall index as a result of the increase to the price of beer (8.37%) and Distilled Spirit (72.73%). The average price of beer increase from \$2.03 to \$2.20 and for Distilled Spirit, it increases from \$22.00 to \$38.00.

The total group total contribution resulted from items-to-price with change in price is 5.78.

Clothing & Textiles

This group recorded a quarterly increase of 0.47% (from 1342.98 to 1349.30). The only commodity affected this group is Girls Primary School Uniform which increases from \$11.35 to \$15.00 (32.16%). Item-to-price contribution for this commodity and therefore the whole group is 0.18.

Transport

The group index recorded a decrease from 1178.65 to 1156.45 (-1.88%). Petrol has the most effect to this decrease with price decrease from \$1.80 to \$1.75 (-2.78%) with a contribution of -2.3. Diesel has a minor effect to the changes in the group index with positive contribution of 0.251. Diesel price increases from \$1.70 to \$1.85 (8.82%).

Total contribution for this group is -2.13.

Housing

Two sub groups have effect to the group; House Maintenance and Fuel & Electricity. Commodity Timber under House Maintenance increases its price from \$2.10 to \$2.60 resulting in a quarterly change of 23.81%. Timber has a contribution of 2.38. For subgroup Fuel & Electricity, two commodities contribute to the effect on the subgroup; Kerosene and Butane Gas. Kerosene has a quarterly price increase of 6.25%

from \$1.60 to \$1.70. However it is the opposite for Butane Gas which has a quarterly price decrease of 20.41% (i.e. from \$49.00 to \$39.00) and with a contribution of -2.14

The group total contribution resulted from items-to-price with change in price is 2.19.

CONCLUSION

This Consumer Price Index shows an increase of 1.26% for the last quarter of 2007 as compared to the increase of 0.38% for the previous third quarter, 2007. The annual inflation rate from the same fourth quarter of 2006 to this fourth quarter of 2007 is **0.48%**.

Three of the six major groups an increase in the November 2007 quarter. The most significant increase came from Alcohol (up 6.09%), Food (up 1.73%) and Housing (up 1.21%) and clothing & textiles (0.47%). One major group which shows no difference is Miscellaneous with an index of 985.15. Transport for this quarter opposes the increase with a downward decrease of 1.88%.

The most significant individual upward increase comes from distilled spirit (up 72.8%), English cabbage (up 57.9%), girl's primary school uniform (up 32.2%), timber (up 23.8%), lamb neck (up 14.9%) and salt beef (up 11.11%). The cost of distilled spirit has increase because of the change of the country of import from Fiji to NZ. Because of the lack of supply for English Cabbage within Australia (due to bad growing condition in some areas) where supply comes from, the price for this item increases. The growing demand for timber from Asia has contributed to the increase in price for Timber where most (80%) of our supplies come from. Lamb neck has gone up its prices because of the short of supply within NZ where most of our frozen meet comes from.

The most significant individual downward contributions come from petrol (down 2.77%). This is because world supply of oil has been gone up to meet the demand for oil (mainly USA). Other individual items with major downward contributions are potatoes (down 13.6%) and pears (down 12.2%). The reason for this downward decrease is because there is excess supply in NZ (due to good conditions in growing areas for these two commodities) where 87% of our supplies comes from.
